## Summary of Findings

Amy Leah Block DeLoach is a 59-year-old woman living in Wilmington, NC. According to her biography, her family has a long history in Wilmington, where her father served in the State Senate, her grandmother on the city council (and has the local USO named for her), and her mother spent her adulthood on local, charitable projects for the area.

About three decades ago, she married John “Mark” DeLoach, a man working in finance. Over the years, his work took them to Charlotte, NC, and from 2006 to 2011, they were living in Laguna Niguel, a bedroom community in South Orange County. In late 2011, they returned to Charlotte before relocating to Wilmington in the last couple years.

A financial disclosure submitted by DeLoach in March 2022 indicates that in the last few years she found a career in managing the family’s real estate rentals, for which she reported rental income. Despite describing her husband Mark as retired, their income includes money from PNC Bank for wages, other income, and stock dividends. In addition, they own stock exceeding \$10,000 in several businesses, including Pfizer, Google, and Abbvie, and they have interest in three properties, one in Mecklenburg County and two in New Hanover County, one being their primary residence.

While the DeLoaches spent five years in Southern California more than a decade ago, property records show they lost money on the nearly 4,000 square foot home they purchased in Laguna Niguel. They obtained a mortgage at \$1.34 million on a \$1.675 million purchase in June 2007 and later sold the home for just \$1.31 million in February 2011. A home in Charlotte was transferred into the names of two of their children, Katie and William, in March 2021.

The DeLoaches do not appear to be the subject of any major legal issues. DeLoach does not appear in any traffic filings in recent years. In 1983, she was the subject of a traffic ticket for speeding over 80 mph OR exceeding the speed limit by more than 15 mph. Additionally, one of the family businesses evicted a resident in 2019, after previously dismissing an eviction cause against him.

DeLoach appears to have not decided about running for North Carolina House until earlier this year. She did not establish a campaign-finance committee until mid-March 2022, and her origination filing detailed a March 2022 meeting with the Timothy Williams, a man who became her campaign manager and also works as a soccer coach. In the first quarter of 2022, which for her campaign meant about six weeks, DeLoach raised nearly \$50,000. As of April 30, 2022, DeLoach had more than \$40,000 cash on hand.

A review of DeLoach’s contributions to other indicated that she gave more than \$3,400 to federal candidates and committee. While nearly all of these contributions were given to Democrats, in 2019, she gave \$500 to Thom Tillis.

## Biography

Taken from press release announcing her bid for office:

**Amy Block DeLoach is excited to announce her candidacy for North Carolina State House, District 20.**

As a native of New Hanover County, serving the Wilmington and Wrightsville Beach communities runs in Amy’s blood. Amy’s grandmother, Hannah Block, served the community as Mayor Pro Tempore of the Wilmington City Council, supported our troops during WWII at the USO (now the Hannah Block Historic USO), and helped create key events for the Azalea Festival, among many others.

Amy’s father, Frank Block, who is announcing his endorsement of Amy today, employed hundreds of New Hanover County residents at the Block Southland shirt factory before serving three terms in the North Carolina State Senate.

Amy’s mother, Wendy Block, served our community on the boards of Thalian Hall and the NC Battleship Commission. She led the efforts to raise money to build Wilmington’s Hospice facility as well as funding for a wide variety of other charities. Both Hannah and Wendy were awarded the Order of the Long Leaf Pine by the Governor for their lifetimes of service to our communities, including North Carolina overall.

Amy has continued this tradition by serving on the boards of The Children’s Museum of Wilmington and the Bellamy Mansion Museum. She has also served on the Advisory Council of the Rape Crisis Center of Coastal Horizons Center, and as president for elementary, middle, and high school PTAs at her children’s schools. Amy currently volunteers with A Safe Place, an organization that combats human trafficking in our community, and is serving as President of Bnai Israel Congregation. Amy is excited to be continuing her family’s tradition of service by

joining the race to serve as a member of the North Carolina House of Representatives representing House District 20.

Beyond tradition, Amy has stated “I’m running for this seat because too many common-sense policies, like expanding Medicaid, are being passed over in the General Assembly while dangerous partisan policies, like banning books in schools loom.” If elected, Amy will put the interests of her district above partisan politics. She will fight for policies that members of the Wilmington and Wrightsville Beach communities, and indeed all of North Carolina, need such as protection of our water, improving education and childcare, expanding access to healthcare and protecting women’s reproductive rights.

Amy will listen to voters in shaping her priorities. She views honesty as a central component of service and will remain accessible to voters who wish to discuss their concerns and ideas.

With the principles of service, commitment, and honesty, Amy Block DeLoach is excited to be throwing her “hat in the ring” for North Carolina State House of Representatives from District 20.

### **Voter Registration**

DeLoach registered to vote in New Hanover County on August 31, 2020 (ID: 0000000441215). Her voter history, however, shows participation dating back to 1994 between Mecklenburg and New Hanover Counties. She has always pulled a Democratic ballot during primary elections and is affiliated with the Democratic Party.

DeLoach also shows a large gap in her voter participation, from May 2005 to November 2012. Based on property records, DeLoach and her husband moved to Orange County, CA during that time and resided in Laguna Niguel.

DeLoach's expenditures appear to be relatively normal campaign expenses. She paid Timothy Williams, a soccer coach with the Wilmington Hammerheads, to serve as her campaign manager on March 31, 2022. Later, the North Carolina Democratic Party made an in-kind contribution totaling \$4,562.14 to cover his salary. Her expenditures also include information about parking to meet with Representative Deb Butler.
