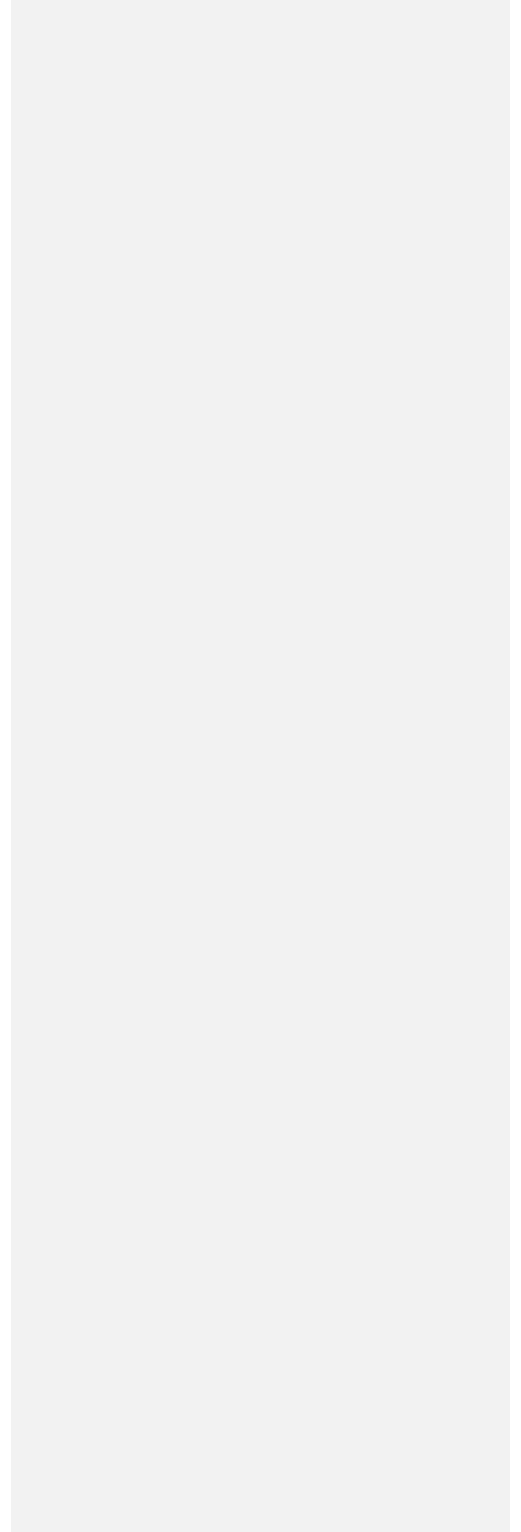
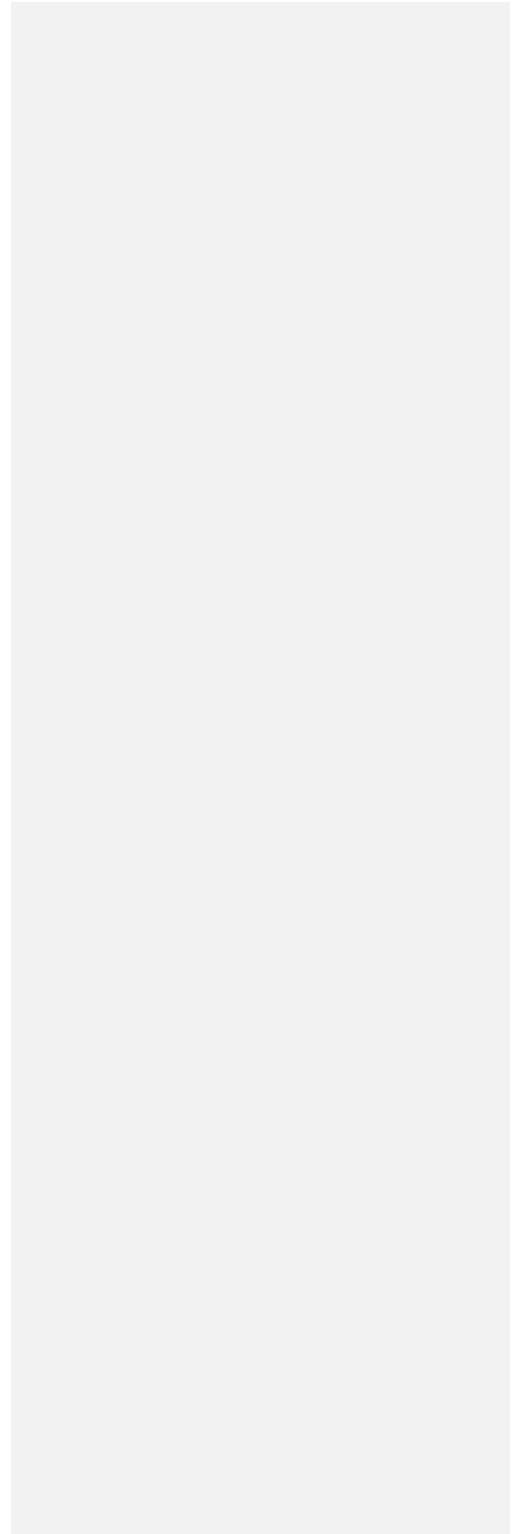

Summary of Findings

Brannon “Ray” Jeffers is a 38-year-old former Person County Commissioner who resides in Roxboro, NC with his wife, Treco Lea-Jeffers, the 48-year-old Director of Earl Bradsher Preschool (part of the public school system). Raised in Person County, Jeffers is a fraternal twin to Brandon Jay Jeffers, a barber in Durham, NC.

In 2008, Jeffers made headlines around the state when he was elected to the Person County Commission at age 25-years-old. He served leadership roles in the statewide County Commission organization in 2013 and 2014. By 2020, however, the demographics in Person County changed, and where the county elected Democrats almost exclusively before, a slate of Republicans was elected to the board, leaving Jeffers unemployed.

According to a statement of economic interests, Jeffers and his wife do not have any children. He is employed by RAFI-USA, a non-profit focused on stopping the exploitation of rural individuals and their food supply. His LinkedIn profile shows that he began with the group in June 2021, about six months after he left the Person County Commission.

Property records indicate that the home where Jeffers is registered to vote is owned solely by Treco. She and her ex-husband purchased the property in 1998. They remained co-owners of the home until 2011, when he and his new wife signed a quit claim deed to give Treco exclusive use of the home. Jeffers received a parcel of land from his mother in 2021, although he has never lived on the property.

As a young man, Jeffers pled guilty to a misdemeanor for passing a bad check at a veterinary clinic in 2004. He paid restitution and court costs tied to the case. He was also the subject of at least five traffic cases, including at least three speeding tickets. He was not prosecuted for driving without insurance and failing to restrain a passenger under 16-years. The only other information listing Jeffers legally involved his father’s 2017 estate, in which he served as administrator. Whether it was a result of COVID delays or Jeffers own sluggish efforts, the relatively small estate was not finalized until late 2020 and only disbursed about \$1,300 after paying expenses and taxes.

2022 marks Jeffers’s second attempt at House District 2. In 2014, he launched a bid for the seat and won a three-way primary. He raised more than \$100,000 for the race, including significant funds from the North Carolina Democratic Party, before losing the general election by 13 points. More notably, however, was the complete ineptitude of Jeffers and his campaign treasurer, David Haynes, an IBEW organizer. After losing the race, the two failed to file a closing report for 2014, receiving an initial \$500 fine by mid-2015. They later failed to file additional reports covering the next several reporting periods, losing the committee’s active status. In accessing penalties, the letters from the North Carolina State Board of Elections were returned to sender.

It wasn’t until February 2017 that Jeffers complied with NCSBE demands and filed closing reports for 2014 and a termination report covering the first ten days of 2015. At the close of his campaign, the account was operating with an \$1,100 deficit. Rather than pay this amount, his records show that SunTrust credited the account before they closed it.

Experienced in Governing

Ray Jeffers is a native of Person County. Ray attended Person County Schools, Piedmont Community College (PCC), and North Carolina Agriculture & Technical State University (A&T). Ray was motivated to join the political realm due to his school affiliations with extracurricular clubs and organizations and his volunteerism.

With Person County being his home, Ray wanted to help ensure that Person County was the best possible place to live and work. Ray served for 12 years as a Person County Commissioner and Chairman of the Board in 2020. In 2008, Ray was the youngest commissioner elected in North Carolina.

In August 2013, Ray was sworn in as the 97th President of N.C. Association of County Commissioners. The first elected from Person County to serve and the youngest in the Association's history. As a Commissioner, Ray supported commonsense policies for economic development, education, farmland preservation, senior services, small businesses, and public safety.

As a Commissioner, Ray was fiscally responsible with the county's budget, promoted tax base growth, and expansion of employment opportunities for the county. Ray has served on numerous local, state, and national boards.

Voter Registration

Jeffers registered to vote in Person County on October 11, 2002 and is affiliated with the Democratic Party (ID: 000000030342). Since that time, he participated in two elections each even year and always pulled a Democratic ballot. It is unclear if he skipped any “second primaries” or off-year, municipal elections.

Jeffers completed and submitted a statement of economic interest to the North Carolina Ethics Commission on March 14, 2022.

Employer and Occupation

Jeffers works as a policy and program manager for Rural Advancement Foundation International – USA, a non-profit.

Family

The only other person living in Jeffers's home is his wife, Treco Lea-Jeffers, a director at Person County Schools.

Property Interests

The Jeffers own 100% interest in a parcel Roxboro, Person County, North Carolina.

Liabilities

Currently, Jeffers does not hold any loans exceeding \$10,000.

Non-Profit Involvement

In addition to his work as an employee at Rural Advancement Foundation International – USA, Jeffers is also a board member at The N.C. Rural Center, an organization that does work with the State of North Carolina.

Property Records

Jeffers and his wife do not co-own the home where they currently live. It was purchased by Treco and her ex-husband, Robert Walker Jr. in August 1998. In 2011, he and his new wife transferred it to her, solely.

In February 2021, Jeffers's mother transferred to him a parcel of land in Person County with a mobile home on it.

Because the Jeffers' primary residence is in Treco's name, part of a 2011 quit-claim deed, we also searched her name in Person County.

- Treco and Robert Walker Jr. purchased a parcel described as 1-acre in Cunningham Township from Martha Winstead on August 21, 1998.
- Treco and Robert Walker Jr. secured a line of credit on their home on Concord-Ceffo Road totaling \$74,746.30 on August 19, 1998 through Beneficial Mortgage Company.
- Treco and Robert Walker Jr. secured a loan through Beneficial Mortgage Company of North Carolina on October 25, 2002 totaling \$21,428.10 and secured on APN: A25-193.
- On November 15, 2002, Beneficial Mortgage Company released a loan signed by the Walkers on October 25, 2002.
- Robert Walker Jr. and Rachel Jane Walker signed a quit claim deed transferring a parcel at 1138 Concord-Ceffo Road, Roxboro, to Treco C. Lea (aka Treco C. Walker) on March 1, 2011. Robert was Treco's ex-husband.

Probate

Following the death of his father, Jeffers petitioned to become Administrator of the Estate for Levi Jeffers, who died on March 11, 2017. After multiple extensions, the case was finalized with disbursements of \$1,322.21 on November 23, 2020.

RAFI-USA

Jeffers lists his employer as RAFI-USA, a non-profit utilizing a post office box in Pittsboro, NC. His biography appears on the organization's website as their policy and program manager.

Ray was born and raised in Person County, NC, where he also operates the family's century farm purchased by his great grandfather in 1919. Previously Ray served for 12 years as an elected Person County Commissioner (2008-2020), was President of N.C. Association of County Commissioners in 2014, and was an executive board member of the National Association of Counties. Ray continues to serve on several local and state boards promoting agriculture and rural communities. Ray attended Piedmont Community College and North Carolina Agricultural and Technical State University.

The organization appears to be focused on “challenging the corporate structure” of the United States that “exploits” rural communities for their agriculture industry. It supports the small, environmentally-sound farm system.

According to Jeffers's LinkedIn profile, he only began with the organization in June 2021, about six months after he left the Person County Board of Commissioners. The most recent tax filing for the organization, calendar year 2019, reflects information at least 18 months prior to him joining the group. The non-profit appears financial solvent, with \$3 million in assets at the close of 2019.

Farm Subsidies

Jeffers indicates that he continues to work his family's “century farm” that his great grandfather purchased in 1919 in his biography on the RAFI USA website. Despite his father and some other family members receiving *de minimis* subsidies about twenty years ago (less than \$200 for Levi Jeffers), the Environmental Working Group does not show that Jeffers was the recipient of any federal farm subsidies during the past 35 years.

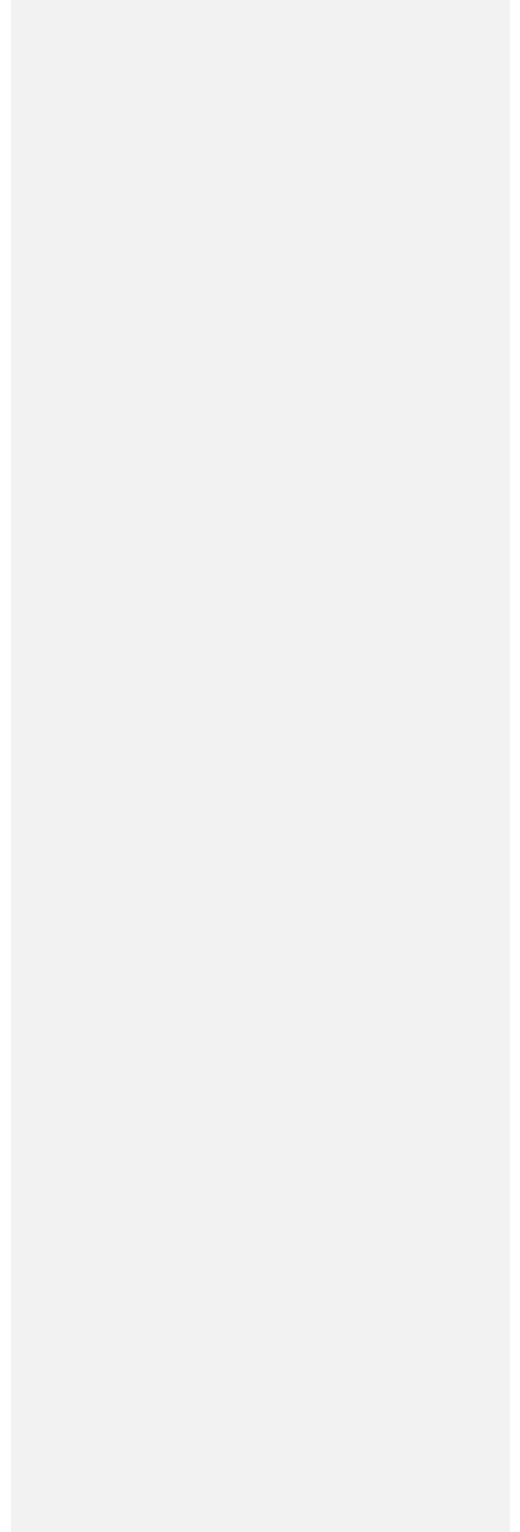
The North Carolina Rural Center

While Jeffers appears on the website as a member of the NC Rural Center's Board of Directors, he is a recent addition (*source: <https://www.ncruralcenter.org/staff/ray-jeffers/>*). He does not appear in the group's most recent IRS 990 covering July 1, 2019 to June 30, 2020.

The organization is focused on improving the lives of North Carolinians who reside in “rural” counties, or 78 of the state's 100 counties. While several of the organization's goals seem

mainstream – collaborations with government, education, philanthropy, business, faith, and grassroots groups – they also espouse progressive language like diversity, equity, and inclusion.

Despite huge resources and assets that totaled more than \$62 million in June 2020, the group's expenses ran about \$4.4 million, comprised of more than \$2.3 million in staff and board salaries/benefits and just \$55,200 in program grants. (*Source: Part IX: [2020 990](#)*)

Prior Committee

Previously, Jeffers established a campaign finance committee, Ray Jeffers for NC House (ID: STA-U0GK50-C-001) in a bid for House District 2 in 2014. The committee was conditionally closed after correspondence was returned as undelivered in November 2016.

In 2017, Jeffers's committee filed updated reports for each time-period and, finally, a fourth quarter of 2014, which shows the committee operating on a deficit. A terminating report dated in 2017 but covering early 2015 shows that SunTrust Bank issued an "Overdraft Bank Closing Credit" covering the outstanding \$1,012.77.

Despite finally complying, The North Carolina State Board of Elections sent several letters trying to get Jeffers's committee and his treasurer, David Haynes of IBEW, to file reports –

 - \$500 penalty for non-filed report (Mid-Year)

 - Warning of termination of active status if not filed within 20 days
- Non-Compliance Letter – October 19, 2016
 - Threats to committee status
- Penalty Assessment Letter – October 19, 2016
 - \$500 penalty for non-filed report (2016 Mid-year)

It does not appear that Jeffers ever paid the \$1,500 in penalties that were accrued by his committee in 2015 and 2016.

2014 Committee Finance

By our count, Jeffers listed nearly \$94,000 given by Democratic candidates and committees, including the North Carolina Democratic Party. Also, the North Carolina State Employees Union gave Jeffers \$10,000.

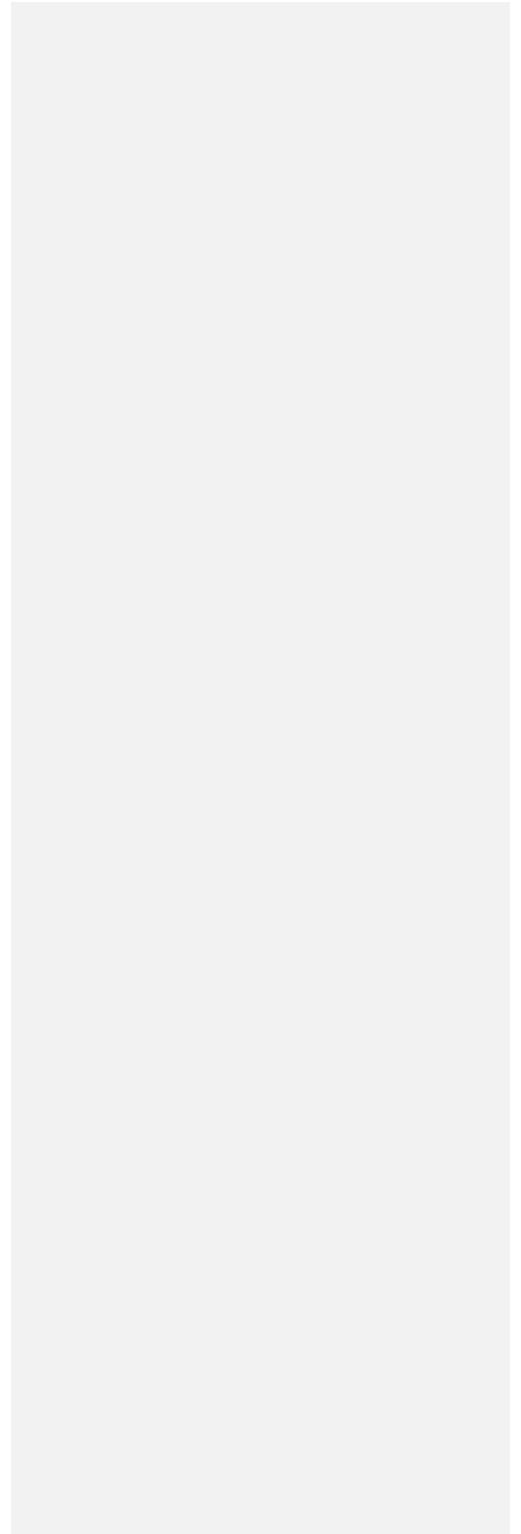
